1. About the Website

- 1.1. Welcome to www.provisionalpsychologistnetwork.com (Website). Access to and use of the Website, or any of its associated Products, is provided by The Provisional Psychologist Network. Please read these terms and conditions (**Terms**) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Products, immediately.
- 1.3. The Provisional Psychologist Network reserves the right to review and change any of the Terms by updating this page at its sole discretion. When The Provisional Psychologist Network updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

2. Acceptance of the Terms

You accept the Terms by remaining on the Website.

3. Bookings for Services

- 3.1. The Provisional Psychologist Network requires all bookings and purchases for the Services to be made via the available booking system (**Booking System**).
- 3.2. To create an account with the Booking System, you are required to e-mail contact@provisionalpsychologistnetwork.com with your full name, e-mail address and phone number and The Provisional Psychologist Network will create an account for you with the Booking System and provide you with the relevant login details.

4. Cancellations, Rescheduling and Refunds

4.1 Cancellation or Rescheduling by The Provisional Psychologist Network

- (a) A minimum of 3 bookings for a group supervision service must be made for the Services to proceed. You acknowledge and understand that The Provisional Psychologist Network will cancel the Services if there are insufficient numbers. If this does occur, you will be entitled to reschedule your booking to a different date or, if this is not suitable, you will receive a full refund of the Purchase Price paid.
